Councilman Tramont expressed his concerns with waiving fees as he is trying to keep the millage rate down.

Councilman Drew Bastian believes Council should follow the matrix they recently approved.

Motion to approve the fee waiver as presented was made by Councilman Drew Bastian and Seconded by Vice Mayor Scott Stiltner. Motion carried unanimously by roll call vote.

Councilman Chase Tramont asked for a cost analysis of changing the baseball fields to clay. Jake Johansson, City Manager, asked if he's interested in clay or fixing any possible drainage issues. Councilman Chase Tramont said clay will absorb the water and make the fields safer and playable.

Mayor Donald Burnette gave kudos to Parks and Recreation for their work on the Halloween Trunk or Treat event. He also thanked Halifax Health for their offer to provide shade canopies at Riverwalk Park.

21. City Manager Comments

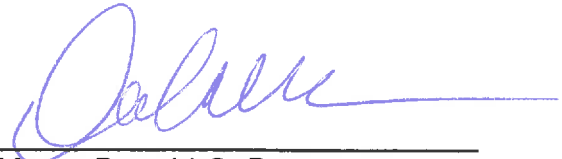

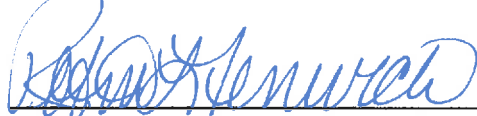
