CITY DEPARTMENT OF PUBLIC UTILITIES SHALL BE NOTIFIED 48 HOURS PRIOR TO ANY EXCAVATION. COORDINATION FOR ANY REQUIRED INSPECTIONS FOR OPEN CUTS, SIDEWALK REMOVAL/REPLACEMENT, AND/OR CURB CUTS WILL BE PERFORMED BY THE PUBLIC UTILITIES DEPARTMENT. ALL OPEN PAVEMENT CUTS SHALL CONFORM TO CITY CODE AND BE COMPLETED WITHIN THREE CALENDER DAYS UNLESS OTHERWISE SPECIFIED ON THIS PERMIT. ALL OTHER REPAIRS AND RESTORATION WILL BE PERFORMED WITHIN SEVEN CALENDER DAYS TO AS GOOD OR BETTER THAN EXISTING CONDITIONS.

PUBLIC UTILITIES WILL BE NOTIFIED ON THE COMPLETION OF ALL RESTORATION SO AN INSPECTION MAY BE PERFORMED. PERMITTEES WHICH DO NOT COMPLETE RESTORATION WORK IN A TIMELY MANNER OR DO NOT PROPERLY NOTIFY THE CITY WHEN COMPLETE, MAY INCURE FUTURE DELAYS IN PERMITTING AND POSSIBLY MONETARY CHARGES FOR WORK PERFORMED BY THE CITY FOR THE PROTECTION OF THE SAFETY AND HEALTH OF ITS RESIDENTS. THE APPLICANT AGREES TO COMPLY WITH ALL CITY CODES AND ORDINANCES. CONTRACTOR IS REQUIRED TO CALL FOR UTILITY LOCATES 48 HOURS BEFORE DIGGING. THE CITY RESERVES THE RIGHT TO CANCEL THIS PERMIT IF PERMIT CONDITIONS ARE VIOLATED AND/OR THIS PERMIT MAY BE SUBJECT TO FIELD ADJUSTMENTS TO PREVENT CONFLICT WITH EXISTING UTILITIES.

NO SIDEWALKS, DRIVEWAYS, ROADWAYS, OR OTHER HARD SURFACES SHALL BE DISTURBED UNLESS CLEARLY DEFINED AND APPROVED BY THIS PERMIT.

APPLICANT HEREBY AGREES TO SOD AND RESTORE ALL DAMAGES TO RIGHT-OF-WAY, SIDEWALKS, STREET, ALLEY, PIPELINES, ETC. WHICH MAY RESULT FROM THIS WORK.<sup>i</sup>
