RESOLUTION NO. 06-63

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PORT ORANGE, VOLUSIA COUNTY, FLORIDA, ESTABLISHING REVISED CHARGES AND FEES RELATING TO MUNICIPAL GOLF COURSE FOR RESIDENTS AND NONRESIDENTS; PROVIDING FOR REDUCTION OR WAIVER OF FEES; SUPERSEDING PRIOR RESOLUTION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Section 166.201, Florida Statutes (2000), provides for municipalities in the State of Florida to impose user charges or fees by ordinance; and

WHEREAS, Chapter 50, Article IV, Code of Ordinances, City of Port Orange, Florida, authorizes the imposition of charges and fees relating to municipal golf course activities; and

WHEREAS, Chapter 50, Article IV, Code of Ordinances, City of Port Orange, Florida, authorizes the amounts of such charges and fees to be established by resolution of the City Council; and

WHEREAS, the City of Port Orange Golf Course Committee and Parks and Recreation Director have reviewed and recommended approval of the golf course charges and fees set forth in this resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PORT ORANGE, VOLUSIA COUNTY, FLORIDA:

Section 1. Pursuant to Section 50-83 of the Code of Ordinances, City of Port Orange, Florida, the following maximum fees are established for use of the municipal

golf course by residents of the City of Port Orange:

Cart rental (per person)	\$12.00 (plus sales tax)

Spouse	\$400.00 (plus sales tax)
<u>Play Pass</u>	<u>Annual</u>

Junior	\$ 305.00 (plus sales tax)
<u>Trail pass</u>	<u>Annual</u>
	\$1100.00 (plus sales tax)

April 1	\$ 600.00 (plus sales tax)
July 1	\$ 300.00 (plus sales tax)

Section 2. Pursuant to Section 50-87 of the Code of Ordinances, City of Port Orange, Florida, the following maximum fees are established for use of the municipal golf course by nonresidents of the City of Port Orange:

<u>Golf Round</u>	<u>Daily</u>
Player (per person)	\$53.00 (plus sales tax)
Junior (per person)	\$20.00 (plus sales tax)
Cart rental (per person)	\$12.00 (plus sales tax)

<u>Discount Card</u> (plus sales tax)	<u>Annual</u> \$50.00 (plus sales tax)

Section 3. Every player using the golf course shall pay a \$1.00 surcharge for each 9 hole round of golf played. These fees shall be in addition to charges outlined in Sections 1 and 2 above. Fifty percent of the surcharge shall be earmarked for capital, renewal and replacement.

Section 4. The City Council hereby authorizes a Start Up Trail Pass when purchased in accordance with the following criteria:

- (a) the purchaser is qualified and complies with the ordinances and golf course rules;
- (b) the purchaser has not previously obtained a Trail Pass or a Start Up Trail Pass at any time;
- (c) no other member of the purchaser's household has previously purchased a Trail Pass or a Start Up Trail Pass at any time; and
- (d) the Start Up Trail Pass is purchased for use beginning on or after January 1, April 1 or July 1. The Start Up Trail Pass shall end on the next successive, September 30.

Section 5. Applicable sales tax shall be added to the fees established in this resolution.

Section 6. Pursuant to Section 50-83 of the Code of Ordinances, City of Port Orange, Florida, the fees established in this resolution may be reduced or waived in accordance with rules and regulations adopted by the city council.

Section 7. This resolution shall supersede Resolution No. 02-08.

Section 8. The charges and fees established in this resolution shall become effective immediately upon adoption.
