The following represents a list of cases that have been pending/filed against the City of Port Orange and does not include workers compensation (Finance Department) or garnishment proceedings (Human Resources). **New items received since last report are highlighted in bold.**

Fink, Shellie K. vs. City of Port Orange, et al
Case No. 2006-31127 CICI, Div: 31
Attorney: Allen Norton and Blue-

Plaintiff was employed by the RCC has filed suit against the City alleging pregnancy discrimination, gender discrimination and violation of the family and medical leave act. Fink is not an employee of the City.

Lamar Advertising vs. City of Port Orange
Case No. 2004-31518 CICI, Division 32
Attorney: Michael Roper, Bell, Leeper & Roper, P.A.

Lamar had several billboards destroyed by recent hurricanes, one of which is on I-95 just south of Dunlawton. The City did not grant building permits to Lamar to rebuild the structures as they were "non-conforming" and more than 50% destroyed according to City Code. Lamar filed suit seeking relief from the Court and damages. Lamar rebuilt all but one sign without permits. **The Court is scheduling a non-binding arbitration hearing for January 2007.**

Dennis K. O'Donnell vs. City of Port Orange, etc.

Plaintiff filed suit alleging an oak tree limb located on city property broke off on May 11, 2004 and damaged a fence and several cars located on his property. Plaintiff claimed damages under \$15,000. The case went to trial in June 2006. Judgment entered in favor of the City of Port Orange.

Plaintiff has filed suit claiming she was injured October 27, 2003, when she tripped on an uneven sidewalk located at City Center. The case has been forwarded to insurance defense counsel. City expects mediation to be scheduled.

Plaintiff has filed suit as a result of an automobile accident on March 27, 2005, on State Road 421 near its intersection with State Road 5A. Plaintiff was a pedestrian crossing State Road 421 when he was struck by a vehicle owned and operated by Betty M. Fair. Plaintiff alleges roadway was dark because street lights were not working.
