SUBJECT: July 4th Firework Celebration

RECOMMENDED MOTION:

Waive bid procedure for a sole source acquisition of the fireworks for the July 4th celebration.

SUMMARY:

As the City has done in the past, we have received a letter from Fireworks by Santore to assist in co-sponsoring the July 4th firework Celebration, with their "in kind" match of \$.50/\$1.00 spent. Council has previously approved waiver of bid procedure and awarded the sole acquisition of those fireworks to Santore in the amount of \$20,000.00. Staff again requests Council authorize this acquisition of the July 4th fireworks to Fireworks by Santore Inc. for that amount.

Funding for this for this has been budgeted in the 410-6100-534-4803 account.


