the Program in the manner described in the proposal and any plans and specifications attached  
thereto unless prior approval for any change has been received from the District.

3. That it has the ability and intention to finance its share of the cost of the project and that the project will be operated and maintained at the expense of said

**SUMMARY:**

The City seeks assistance from the FIND grant program to design and permit a canoe launching facility and ADA walkway ramp at the Russell property.

The design and permit costs associated with this project total **\$44,000.00**. The City is requesting **\$22,000.00** from the FIND program and matches the request with **\$22,000.00** in cash. *this transaction is subject to budgetary appropriation.*
